### **PROVISION OF SETA ACCREDITED TRAINING AS PER BELOW TERMS OF REFERENCE**

#### **1. PROJECT OBJECTIVES**

The overall objectives of the project are to;

- Ensure that accommodation establishments get the necessary support in food handling.
- That inspection for is kitchens is done in order to avoid food contamination and food poisoning.
- To improve the kitchen standards of the accommodation establishments supported by EDM.
- To ensure compliance of accommodation establishments, by also assisting them with acquiring environmental health and compliance certificate.

#### **2. SCOPE OF WORK**

The project requires the implementation of a support program that will focus on supporting guesthouses within Ehlanzeni District for the remaining four months of the programme in the 2020/2021 financial year. The results of the programme will aim to achieve the following outcomes:

- Assist struggling guesthouses that are within the parameters of Ehlanzeni District Municipality.
- Improve the compliance of the guesthouses in food, health and safety handling.
- Ensure that guesthouses comply and have certification necessary for kitchen use and food handling.
- Identification of needs and gap analysis for guesthouses and supporting them accordingly.

#### **3. OUTCOMES AND EXPECTATIONS**

The Service provider will be responsible for;

- The identification / approval of guesthouses to be supported in the program.
- Conducting an in-depth assessment of the guesthouses and identify gaps and support needs of each of them.
- The development of a guesthouse support plan through training and in-depth support where necessary.
- Assisting accommodation establishments with compliance and certification for food handling and the kitchen.
- Conduction one on one assistant support as well as accredited training for the accommodation establishments to be assisted for the period of four months.
- Review progress of the support continuously, updates and feedback to Ehlanzeni District Municipality through submission of monthly reports.

#### **4. EXPECTED DELIVERABLES**

The service provider will be expected to;

- Submit the implementation plan with measurable deliverables for the overall project/program;
- Facilitate the training sessions and one on one interactions with the accommodation establishments to be assisted.
- Deliver completed gaps analysis report of each establishment
- Identify specific support plan and developmental needs to address the individual constraints
- Schedule regular visits to guesthouses in order to support and address identified constraints
- Submit monthly progress reports on the project to Ehlanzeni District Municipality
- Submit a final report and recommendations for each guesthouse.

1.6. The purchaser reserves the right to require a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

**2. DEFINITIONS**

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
