**The following are the terms of reference for the required civil litigation services:**

1. Provide constant legal advice to the Municipality with regard to the matter in question.
2. Drafting and filing of the relevant court papers (issue summons and particulars of claim, as well as all subsequent court pleadings that may be necessary when processing the matter), in terms of the rules of the High Court of South Africa to claim the amount due in favour of Ehlanzeni District Municipality, following failure by service provider (to be only disclosed to the successful bidder) to pay the guarantee amount due as claimed in the demand for payment letter;
3. Facilitate necessary consultations with the Municipality, witnesses as well as any other relevant stakeholder where necessary;
4. Submit written progress reports to the Municipality;
5. Professionally and diligently perform the services of an attorney in the subject litigation;
6. Draft heads of arguments in relation to the matter;
7. Appearing in Court as a legal representative of the Municipality and saucing services of Counsel to be part of the legal team should there be a need (to be pre-approved by Municipality).

**REQUIREMENTS**

1.6. The purchaser reserves the right to require a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

**2. DEFINITIONS**

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;

- (f) **“functionality”** means the ability of a quotationer to provide goods or services in accordance with specifications as set out in the quotation documents.
