- This invitation for quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000).
- All prospective bidders must provide a copy of a signed letter of commitment to supply the required goods from an accredited or authorized manufacturer/distributor/reseller of the required goods in order to be considered for appointment.
- Prospective service providers are required by law to complete all the attached MBD forms which must be completed and submitted together with your quotation.
- **Only locally produced or locally manufactured Textiles, Leather and Footwear as well as Steel Products meeting the stipulated minimum threshold for local production and content will be considered and the minimum threshold for local production and content in terms of DTI classification for both is 100% for the above bid.**

1.6. The purchaser reserves the right to require a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic

empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;

- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;

 - 1)BBEE Status level certificate issued by an authorized body or person;

y is the bid price in Rand excluding value added tax (VAT)
