TERMS OF REFERENCE FOR THE GUESTHOUSE SUPPORT PROGRAMME

1. BACKGROUND

There is growing recognition of the important role guesthouses play in the tourism industry. Guesthouses being in the tourism industry are a great contributor to the Growth Domestic Product (GDP) and as such, they create jobs and contribute immensely to the reduction of unemployment. Despite the potential role of guesthouses to accelerate growth in the tourism industry and create more jobs in developing countries, a number of bottlenecks affect their ability to realize their full potential. Guesthouse development is hampered by a number of factors, including finance, lack of managerial skills, equipment and technology, regulatory issues, and access to international markets non-compliance and now the outbreak of Covid 19

Despite the potential role of guesthouses to accelerate growth in the tourism industry and create more jobs in developing countries, a number of bottlenecks affect their ability to realize their full potential. Guesthouse development is hampered by a number of factors including finance, lack of managerial skills, equipment and technology, regulatory issues, and access to international markets

The lack of managerial know-how places significant constraints on guesthouse development. Further support services deficiency can hamper guesthouses' efforts to improve their management because consulting firms are often not equipped with appropriate cost-effective management solutions for guest houses. Besides, despite the numerous institutions providing training and advisory services, there is still a skills gap in the accommodation sector as a whole. This is because entrepreneurs/product owners cannot afford the high cost of training and advisory services while others do not see the need to upgrade their skills due to complacency.

2. PROBLEM STATEMENT

Smaller tourism business establishments continue to struggle in the current economic environment and find themselves closing down or being liquidated due to lack of sustainability and suffer from disadvantages larger tourism business chains are not exposed to.

It is with this in mind that **Ehlanzeni District Municipality** together with its other stakeholders have identified the guest house support program as a key aspect of economic growth and development. This project focuses on a support initiative that sets out to assist the ability of guesthouses to create wealth and thereby impacting positively on job creation, promoting innovation and technological advancement.

3. MAIN AIM OF THE PROJECT

This project is aimed at ensuring that small businesses such as guesthouses continue to operate and remain sustainable with enough support from both private and public organizations thus sustain and

possibly increase work opportunities and diversity within the tourism sector. In this regard, they will address skills and enterprise development within the accommodation sector.

4. PROJECT OBJECTIVES

The overall objectives of the project are to;

- Ensure business sustainability through a support program that will seek to address financial viability challenges;
- Increase and maintain work opportunities within current establishments in the sector;
- To enhance the skills of staff at the establishments;
- To ensure tourism accommodation remains diverse in offering and pricing;
- To promote and market smaller business establishments through joint marketing initiatives and organized marketing platforms.

5. SCOPE OF WORK

The project requires the implementation of a support program that will focus on support for seven (07) guesthouses within Ehlanzeni District (City of Mbombela and Bushbuckridge local municipality) from September 2021 through June 2022. The results of the programme will aim to achieve the following outcomes:

- Improve the management of the guesthouses that will be identified for the program;
- Service excellence from guesthouses thus resulting in successful completion of contracts;
- Quality service assurance and compliance.

6. OUTCOMES AND EXPECTATIONS

The service provider will be responsible for;

- Conducting an in-depth assessment of and identify gaps and support needs of each of the guest houses to be supported (which will be identified by Ehlanzeni District Municipality).
- The provision of mentorship and training to owners and staff members of the identified guesthouses.
- Development of a guesthouse support plan that addresses individual constraints and capacitate guesthouse management to become a successful business entity that realizes all relevant business opportunities within the tourism sector;
- Assisting guesthouses to enter into the mainstream economy through the market and big business linkages;
- Conducting one on one support over the period of the mentorship programme in order to ensure transferal of knowledge from the mentor to the guesthouse management;
- Review of progress of the support continuously, updates and feedback to Ehlanzeni District Municipality through monthly progress reports.

7. EXPECTED DELIVERABLES

The service provider will be expected to;

- Apply for the tender to be advertised by Ehlanzeni District Municipality;
- Attend an inception meeting for the brief of the overall program to be hosted by Ehlanzeni District Municipality together with its stakeholders;
- Submit an implementation plan with measurable deliverables for the overall project;
- Facilitate an induction session/workshop for guesthouses to be supported;
- Deliver completed gap analysis report of each guesthouse;
- Identify specific support plan and developmental needs to address the individual constraints;
- Schedule regular visits to guesthouses in order to support and address identified constraints;
- Submit monthly progress reports on the project to Ehlanzeni District Municipality;

- To submit a final report with recommendations for each guesthouse.

8. EXPECTATION FROM PARTICIPATING GUESTHOUSES

- Each participating guesthouse will assist with travelling arrangements for its staff where necessary.
- Ensure that staff is available for training as and when required.
- Provide an objective feedback to Ehlanzeni on the effectiveness of the training.
- Provide reasonable assistance to the training project as it unfolds.

The duration of the programme is September 2021 through June 2022.
