### APPOINTMENT OF SERVICE PROVIDER FOR THE SUPPLY AND DELIVERY OF PROTECTIVE CLOTHING TO WASTE PICKERS (RE-ADVERTISEMENT)

#### EHLANZENI DISTRICT MUNICIPALITY HEREBY INVITES PROSPECTIVE BIDDERS FOR THE ABOVE-MENTIONED TENDER

Only bidders who have provided the following mandatory information and documents to be used to evaluate the bidder's responsiveness will be considered for further evaluation on functionality:

- Central Supplier Database (CSD) Registration Report
- Valid SARS PIN
- Certified copies of company registration documents from the Companies and Intellectual Property Commission (CIPC) and bidders must attach certified copies of shareholder's certificates where applicable.
- Certified copies of identity documents of company directors
- Joint Venture or Consortium Agreement if applicable
- Fully completed tender document as issued and signed (**Not re-typed**)
- Certified copy of a municipal account not older than three months for both the company and director/s of the company or an original certified copy of proof of residence (PTO) issued by a relevant traditional authority or a copy of a valid lease agreement.
- The bid comprises of local content and production for designated sectors such as locally produced or locally manufactured **steel products (100%); leather and textile (100%)**, and prospective service providers are required by law to complete the MBD 6.2 with its Templates-Annexures C, D and E (Local production), failure to complete the documents will lead to automatic disqualification as the bid will be considered non responsive.

Received bids will be evaluated on responsiveness based on mandatory requirements, functionality with a minimum threshold of **70** points out of a possible **100** points, and price (**80** points) and B-BBEE (**20** points) status level of contribution in accordance with the criteria stipulated on the bid or tender documents in line with the provisions of the Preferential Procurement Regulations, 2017.
