## TERMS OF REFERENCE FOR THE ECD TRAINING

The Convention on the Rights of the Child, Article 31 states that every child has the right to engage in play and recreational activities appropriate to the age of the child. However, play is often undervalued in many learning contexts in early childhood and primary school for a variety of cultural, economic and institutional reasons. Play is crucial for children's development and resilience by supporting their creativity, self-confidence, communication skills, and cognitive functioning. Play that enables children to participate in group learning with their peers and adults can also promote a sense of comfort, Trust, safety and belonging. Play also contributes to improved health outcomes for children by lowering their anxiety and stress levels to support optimal brain development. For these reasons, innovative play-based ECD programming approaches are required to ensure children's right to play are realized, especially among the most marginalized groups of children.

### Scope of work

A service provider who will provide early childhood development training services to 50 ECD practitioners. The training must cover the following:

- Child development;
- Child Care;
- Child protection;
- Minimum standards of child care;
- Health, safety and nutrition;
- Management;
- Active learning;
- Premises and equipment; and
- Minimum standards.
